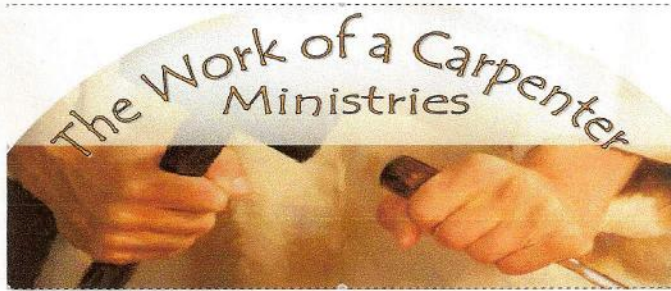

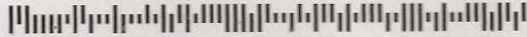

Summer has turned to fall, with all the changes that brings. Guests are beginning to ask for sweaters and jackets instead of T-shirts and shorts. In late August we distributed school supplies to dozens of children. The harvest of late-summer and fall crops continues in our Earthworks gardens—tomatoes, squash, potatoes. Electric bills spiked by high demand for air conditioning will soon be replaced by gas bills inflated by the need for heat.

Our usual programs and services continue, regardless of the weather conditions outside. Hundreds of people eat in our two kitchen/dining rooms each day. Dozens and dozens attend the twice-weekly "Spirituality of the Twelve Steps" sessions held at both the Meldrum and Conner locations. I am writing to express my gratitude for your support of AID Atlanta with your FACP gift per Dwayne Hickman of \$200.00 on April 8, 2016. Generous gifts from donors like you provide the financial support needed to continue our mission.

Laser focused on our community needs, AID Atlanta is committed to engaging those most disparately impacted by HIV by supporting their quest to conquer the stigma and barriers that hinder people from thriving with HIV. Only 73 percent of the people in the Atlanta metro area who have HIV know it, because not enough people are getting tested for the virus due to the continuing stigma around HIV/AIDS in our communities. (The national average is 87%) We continue to work to find people who are HIV+ but unaware of their status, and linking them to medical and social supportive care regardless of their ability to pay. Our prevention efforts, focus on utilizing PrEP education and treatment, prevention and behavioral interventions, and educational programs. We are ensuring access to affordable health care and wrap around services.

Georgia ranks second among U.S. states in the rate of new HIV diagnoses, behind Louisiana, and Atlanta ranks fifth among metropolitan areas with populations of 500,000 or more. The metro-Atlanta region accounts for more than 60% of HIV cases in Georgia. In 2012 there were 39,102 Georgians living with HIV or AIDS.

We achieved significant milestones in 2015 and with your partnership and investment we intend to continue increasing our efforts to empower people to live their best lives.

- Provide testing for 13,000 people with counseling and linkage to care for positive results
- Increase our patients in primary care to 1,500
- Provide an additional 250 clients housing assistance
- Provide access to HIV medications for 500 patients that would otherwise have no means

We hope you share our enthusiasm for expanding our capacity and hope that you will continue to partner with us as we look forward to aggressively pursuing these initiatives.
